## Detailed Membership Terms Code & Code of Conduct

### **1. Membership Commitment**

By enrolling in the **AFLAMDA Studio** paid membership program (“Membership”), you agree to a **12-month membership commitment** beginning on the date of purchase (“Membership Term”). All membership fees are due and payable at the time of enrollment, or on an ongoing monthly basis for one calendar year, unless otherwise specified in writing.

### **2. Payment & Refund Policy**

All payments made for the AFLAMDA Studio Membership are non-refundable. Refunds will only be considered in rare and extreme circumstances, such as verifiable medical emergencies or other significant hardships, and shall be granted solely at the discretion of AFLAMDA Studio. Requests for exceptions must be submitted in writing with supporting documentation.

### **3. Code of Conduct**

AFLAMDA Studio aims to maintain a safe, respectful, and inclusive environment for all members. By joining, you agree to adhere to the following standards:

### 3.1 Prohibited Conduct

The following behaviors are strictly prohibited and may result in immediate revocation of membership without refund:

- **Racism, discrimination, or hate speech** targeting any individual or group.
- **Bullying, harassment, intimidation,** or threats of any kind.
- **Abusive, disruptive, or unsafe behavior** in any AFLAMDA Studio space, online or in-person.
- **Sharing private information,** recordings, or materials from AFLAMDA Studio to individuals or institutions outside the membership without authorized permission.
- **Any conduct that violates applicable laws** or disrupts the integrity, safety, or mission of AFLAMDA Studio.

### 4. Membership Revocation

- Membership revoked due to misconduct is not eligible for refund.
